\$100,001 to \$500,000	\$562 for the first \$100,000 plus \$4 for each additional thousand or fraction thereof, to and including \$500,000
\$500,001 and up	\$2,162 for the first \$500,000 plus \$3 for each additional thousand or fraction thereof.

**WIRELESS TELECOMMUNICATION FACILITY FEES**

Application fees for wireless telecommunication facilities will be as follows:

Towers and Co-locations that Increase the Height of the Structure: \$10,000

Co-locations Which Attach to an Existing Tower or Structure without Increasing the Height of the Tower of Structure: \$5,000
