RFP 16-04-P, Pump Station Floor Replacement

Introduction:

Aiken County Government is requesting sealed proposals from qualified contractors for Aiken County Public Service Authority (ACPSA). Contractor is to replace broken floor tile with an alternative flooring option at the first floor of our pumping station one. The ACPSA is located at 70 PSA RD Beech Island SC. The ACPSA is owned and operated by the County of Aiken SC.

Scope of Service:

The ACPSA is requesting qualified contractors to inspect and evaluate the condition of the existing floor and to make recommendations on flooring options available. The inspection and evaluation should contain the condition of the thickset underlay, flooring options available, cost estimates for each option, durability, warranties and proposed timeframe to complete task.

Scope of Work:

- Remove remaining tile and curbing.
- Inspect and evaluate thickset for flooring options.
- Install approximately 3,600 sq. ft. of floor and grade to seven existing floor drains.
- Install approximately 760 lf of curbing.
- The contractor will be solely responsible for the removal of all debris and any equipment needed to complete the project.
- The contractor shall abide by all ACPSA safety procedures and OSHA regulations.

The ACPSA will use the following criteria in evaluating the proposals:

- A successful record in completing similar projects to the one described in this RFP.
- A list of relevant projects with the name, address and telephone number of a contact person to check references. Please use the reference sheet included in this package.
- Best flooring option based on the decision of the ACPSA Staff.
