MORTGAGE COMPANIES WILL REQUEST AND RECEIVE 2013 TAX BILL FOR PAYMENT OF MORTGAGOR'S TAXES.

ALL 2013 TAXES (EXCEPT MONTHLY VEHICLES) ARE DUE AND PAYABLE BETWEEN 10-21-2013 AND 1-15-2014 WITH NO PENALTY; A 3% PENALTY IS ADDED 1-16-2014 THRU 2-1-2014; AN ADDITIONAL 7% PENALTY 2-2-2014 THRU 3-16-2014; AN ADDITIONAL 5% PENALTY AND ENFORCED COLLECTION AFTER 3-16-2014.

**NOTE: TAX BILLS ARE MAILED TO ADDRESSES FURNISHED BY TAXPAYERS TO THE ASSESSOR'S OFFICE AND FAILURE TO RECEIVE A TAX BILL BECAUSE OF AN INCORRECT ADDRESS OR TRANSFER OF OWNERSHIP AFTER DECEMBER 31, 2012 DOES NOT EXCUSE PENALTIES.**
